FINANCE REPORT:

This YTD fundraising represents part of the Pastor's Anniversary fund (more income to come when we receive the Facebook check)
- Building Expenses (\$786 over budget), major items were
 - Utility/Gas \$350 over budget
 - Building Maintenance \$186 over budget as expenses are \$586 YTD
 - Yard Maintenance over budget \$240 as a 2020 expense was paid in January 2021
